The CSLA/AAPC College of Fellows A Brief History

The first Fellows were elected in 1964, followed by almost annual additions averaging three Fellows per year. By 1979, over 30 members had been honored by election to Fellowship and it was time to formalize the structure and process. At CSLA/AAPC Congress '79 in Charlottetown, the 'College of Fellows' was established. Specific 'Rules for the Conduct of Operations' were adopted, outlining the structure and operation of the College and the guidelines for advancement of members to Fellowship.

The College's Executive Committee is responsible for the conduct of affairs, consisting of the Chair, Vice Chair, Secretary-Treasurer, and the President of the Landscape Architecture Canada Foundation (LACF), as well as the CSLA/AAPC President as ex-officio member. The Annual Meeting of the College is held each year in conjunction with the CSLA/AAPC Congress. An average of 20 Fellows have attended each AGM over the last several years.

Particular attention has been given to the manner in which new Fellows are admitted to the College and the role of the College in the larger activities of the profession and the Society. In accordance with the Rules for the Conduct of Operations, nominations to Fellowship may be presented to the College by the component organizations and/or the Board of Governors of the CSLA/AAPC. The final selection is made by a 'Jury of Fellows', consisting of representatives from Canada's five regions (B.C., Prairie, Ontario, Quebec and Atlantic), who are serving on the Jury for overlapping three-year terms. The Fellows-Elect are then ceremoniously inducted into the College during the banquet or other special event of the next CSLA/AAPC Congress.

Other activities of the College and its members involves assisting in the operation of the Accreditation Council, which administers the accreditation of Canadian schools/departments of landscape architecture since 1987, as well as the LACF. Since the 'Campaign of Fellows' commenced in 1988, over \$330,000 has been donated by Fellows to the Foundation. These funds are used to promote the ideals of the profession of landscape architecture through research and scholarship grants.

In recent years a special effort has been made to establish a profile record on each Fellow, in order to have such information available for present and future generations of landscape architects. These records are on file for 75% of Fellows to date.

Since the inception of CSLA/AAPC, a total of 128 Fellows have been elected, 15 of whom are now deceased.

Criteria for Election to CSLA/AAPC Fellowship

Election to Fellow is the highest honour the CSLA/AAPC bestows on its members. Fellowship is the recognition of members who have made outstanding contributions to the profession over an extended period of time in one or more of the following categories:

Executed Works of Landscape Architecture
Administrative Professional Work in Public Agencies
Professional University Instruction
Professional Writing
Service to the Community or the Public on behalf of the Society
Direct Service to the Society

Richard A. Strong Categories: Executed Works - Professional University Instruction

Mr. Richard Strong obtained a BLA degree from the Ohio State University in 1957 and a MLA degree from Harvard University in 1959. He is licensed to practice landscape architecture in the states of Arizona, Montana and Ohio and is a member of CLARB. Dick was one of the founding members of OALA in 1969 and the association operated out of his offices during its early years. He served on the CSLA Board of Governors, as Chair of CSLA's Education Committee and as member of ASLA's Committee on Education.

The firm Richard Strong Associates Ltd. operated first in Toronto from 1961-78 with up to 35 staff members and in Calgary from 1978-83. In 1983, Dick became Director of Design and Development for the Expo '86 Corporation in Vancouver and was responsible for the design and development of the 135 acre World Exposition site. From 1987-91 he worked in Sydney, Australia as Design Consultant for governments, corporations, engineers and architects. Returning to Canada, he operated a Design Consultant firm in Lethbridge, Alberta from 1991-97. Mr. Strong's firm has been one of the most important practices in the country, with over 2000 projects to its credit. It has served as training ground for many of today's important landscape architects.

Dick Strong was the first Chairman of the Landscape Architecture Department at the University of Toronto from 1967-77. He led the Department through its formative years, emphasizing the widest breath of landscape architectural education. Instructors included aside from landscape architects: psychologists, artists, developers, urban foresters, marketing advisors and politicians. In the ensuing 35 years Dick has lectured and acted as visiting critic at numerous Canadian, American and Australian universities.

As a leading practitioner and distinguished educator for over forty years, we recognize Richard Strong as a giant of our profession and are privileged to bestow on him the long overdue honor of CSLA Fellowship.

David J. Reid

Categories: Executed Works - Professional Writing

Mr. David Reid's 28 years in landscape architecture started with graduation from the University of Guelph in 1975. His first job with Don Graham's group provided such effective training that he became one of the principals of the Landplan Collaborative at the tender age of 22.

David agreed to man Landplan's Vancouver office for three months in 1976. The three months grew to five years in Vancouver and a practice of ten professionals. In 1981 he convinced Landplan to let him start a branch office on Vancouver Island. There were no landscape architects north of Victoria at the time, and David moved to Nanaimo to fill that niche. The descendant firm, Lanarc Consultants, is now a diversified consultancy of ten, with Doug Backhouse as key partner. Lanarc has established a broad consulting practice for local governments and leading developers.

Dave's analytical abilities, multi-disciplinary approach and warm personality elevate him as a team leader and permit him to coordinate diverse professionals in the pursuit of creative solutions to complex design issues. He is probably best known for his publications for senior government clients. Especially here he has made direct and powerful contributions to the advancement of the profession of landscape architecture and to the public recognition of the profession through both his private practice accomplishments and his public practice communications, both in print and digital media.

David Reid is a professional with integrity and an ambassador for the profession. We are proud to honour him with induction into the CSLA College of Fellows.

Andre A. Schwabenbauer

Category: Direct Service to the Society

Mr. Andre Schwabenbauer graduated from the University of Manitoba with a BES degree in 1984 and a MLA degree in 1992. He became a member of the AALA and CSLA in 1991 and served on the AALA executive council from 1994 to 1998 as President-elect, President and Past-president. During his presidency, Andre chaired the AALA committee that negotiated with three other Provincial Associations to rewrite the Architect's Act as an Omnibus Act for four professions and participated in the first accreditation review of the NAIT Landscape Architectural Technologist program. As Past-president he served on the CSLA Board of Governors for two years, contributing significantly to the Society, including his role in co-developing the model internship program and as finance chair for the successful CSLA Congress '97 in Edmonton.

In 2001, Andre was elected CSLA President-elect and promoted the hosting of the 40th IFLA World Congress in Calgary. He also assisted in organizing the Montréal CSLA Congress in 2001, which reduced the financial losses resulting from the cancellation of the joint CSLA/ASLA Congress. During his presidency, Andre was co-chair of the 40th IFLA World Congress, negotiated a new contract for the publication of *Landscapes/Paysages*, represented the CSLA at President's Council meetings in the USA, and commenced negotiations with the ASLA for a new joint conference to be held in Canada.

Andre has been a principal of his own landscape architectural firm in Edmonton since 1989 and received a CSLA National Citation award for a completed project in 2000. We are pleased to recognize Andre's exemplary and dedicated services to the profession at the component and national levels and warmly welcome him into the College of Fellows.

Other requirements for election are a minimum of twelve (12) years uninterrupted membership in the Society, strictly enforced confidentiality of nomination and a confirmative 75% majority vote by the Jury of Fellows. Outstanding contributions are generally considered as contributions that are above and beyond those provided by a member of the profession. Particular attention is paid to those practitioners who have made nationally or internationally recognized contributions.

Marie-Claude Robert completed her BLA degree from the Université de Montréal in 1973 and became a member of the AAPQ in 1982, having already served as the association's secretary for three years. Mr. Domenic Lunardo obtained his Bachelor's Degree in Landscape Architecture from the University of Toronto in 1980. He was accepted a member of the OALA and CSLA in 1984 and member of the American Society of Landscape Architects in 1988. Mr. Lunardo has served as Vice President of the OALA and chaired both the Ethics Committee and the Examining Board of the Association. He also served as Vice-President and Member of the Board of Directors of Parks and Recreation Ontario from 1998 to 2000. In May 2000, Domenic was the recipient of the OALA's Public Practice Award.

Known for his leadership and management skills, Mr. Lunardo has promoted the profession in senior management roles including Director of Parks and Director of Urban Design with the City of Vaughan and more recently as Director of Design and Construction with the City of Hamilton where he has managed large inter-disciplinary consulting teams for the design and construction of municipal buildings and parks.

Professor Mooney obtained a Bachelor of Music degree from the University of British Columbia in 1971and a Masters of Landscape Architecture from the University of Guelph in 1981. He is currently completing his Ph.D in Landscape Architecture at the University of Michigan.

In 1982 he was accepted as a member of the BCSLA. He has been a director of the BCSLA, chaired the Urban Issues and Environment committees, as well as serving on the Examination committee. He has served as vice president of the Canadian Society of Landscape Ecology and Management and as a member of the CSLA Accreditation Committee and is the recipient of several CSLA professional awards.

Patrick began his teaching career at the Kansas State University in 1984, moving to the University of British Columbia, 1986. His teaching responsibilities include design studios, landscape planning and management and planting design. His research, practice and publications focus on the areas of the therapeutic benefits of landscape and ecological restoration for wildlife habitat. He views both areas as components of designing sustainable environments. Patrick advocates broadly for conservation management, working with government, developers and non-profit environmental groups to acquire and manage conservation areas to maintain regional biological diversity. For his work in this area he received the Sanford award from the Vancouver Natural History Society in 2002.

Mr. Alan Duncan graduated with a B.L.A. degree from the University of Guelph in 1973 and a Master of Arts in Planning from UBC in 1990. He was accepted as a member of the AALA and CSLA in 1982, the CIP in 1992, and the BCSLA in 1994.

Active in these organizations over the years, Alan also represented B.C. arborists on an advisory committee to Tree Canada, he frequently instructs in UBC's Landscape Architecture program, and he adjudicates on the national ACT Program Selection Committee.

Alan has worked across Canada – PEI Department of Environment and Tourism, Ontario Hydro, the Planning Departments of Etobicoke and Edmonton, and the Groupe d'intervention urbaine de Montreal. Since 1989, he has worked with the City of Vancouver Planning Department, where he coordinates such landscape policy and public realm projects as regulation of private property trees and the Ridgeway Greenway, both which received CSLA recognition for innovation, and the Wellness Walkway project which last year received a PIBC award for excellence in planning. In 2001, Alan was first recipient of the BCSLA Public Practice Award.

Alan has a long history in grassroots community celebration planning, production and performance. He co-initiated the annual Winter Solstice Parade in Toronto's Kensington Market and was a co-founder and President of the Vancouver-based Public Dreams Society, which received a BCSLA Community Service Award in 1995. Alan continues to animate the urban landscape by performing on stilts despite his mother insisting that he's now too old for that.

John B. Hillier

Category: Executed Works

Mr. John Hillier graduated from the University of Toronto with a B.L.A. (Hons.) degree in 1977. He became a member of the OALA in 1980 and has served on council and various committees.

Following graduation, John joined duToit Associates Ltd. becoming an associate in 1980 and a partner of duToit Allsopp Hillier in 1985. The multi-disciplinary firm of planners, architects and landscape architects focuses on urban design. It has provided a significant contribution to the National Capital. John's role in this work has included the planning and design of numerous components of Confederation Boulevard over a period of twenty years. He also led the landscape and architectural aspects of the historic Laurier Bridge reconstruction.

Mr. Hillier directed the firm's Civic Design Study of Toronto's Gardiner Lakeshore Corridor. Other Toronto projects include the Fort York Boulevard streetscape and urban design for the Spadina LRT and the Front Street extension. Richard Gaudreau completed his undergraduate degree in landscape architecture in 1979, and his masters in environmental development in 1983, both at the Université de Montréal. His professional career has taken him through a wide range of positions including university professor, assistant director and director of different public and private planning agencies, consultant, international advisor, and most recently as economic development officer for one of Québec's regions.

His numerous contributions to the advancement of the profession have ranged from his presidency of the AAPQ in the mid-eighties to his term and restructuring work as president of the CSLA in 1989-90, to his recent term as member of the Board of the AAPQ. Ms. Donna Hinde obtained a BES Degree from the University of Waterloo in 1978 and a MLA Degree from the University of Guelph in 1984. She became a full member of the Ontario Association of Landscape Architects in 1985 and served on the OALA Council for three years, before becoming President from 1998 to 2000. While on Council, she initiated the preparation of a Strategic Plan and focused on enhancing the public profile of landscape architects in community planning and urban design initiatives.

Donna is a Partner at The Planning Partnership, a Toronto-based firm of landscape architects, planners, and urban designers.
