

Emerging Professional Award Nomination Guidelines and Form

Purpose	<p>The Emerging Professional Award demonstrates the CSLA's commitment towards landscape architects in the early stages of their careers. The Award is intended for emerging professionals who:</p> <ul style="list-style-type: none"> ○ have demonstrated professional excellence in the field of practice ○ positively impact their vocations and communities, ○ have shown leadership in the profession, and ○ demonstrate passion and enthusiasm for the profession of landscape architecture.
Eligibility	<p>The individual must be:</p> <ul style="list-style-type: none"> ○ under the age of 40 ○ a landscape architect, and ○ a full or associate member of BCSLA, NWTALA, NuALA, AALA, SALA, MALA, OALA, AAPQ or APALA. <p>INELIGIBLE CANDIDATES Current members of the CSLA Board of Directors.</p> <p>RESTRICTIONS An individual may receive only one Emerging Professionals Award in their lifetime.</p>
Frequency	<p>One award may be awarded annually.</p>
Nomination	<p>Nominations may be made by:</p> <ul style="list-style-type: none"> ● any Member of the CSLA, ● any component organization of the CSLA, ● any organization of the CSLA's allied professions. <p>The CSLA will not accept self-nominations for this award.</p>
Deadline	<p>Nominations must be received at the CSLA office by 4 p.m. (EDT) on 31 March 2021.</p>
Selection	<p>Each nomination is judged by the Board of Directors for the success with which the nomination package demonstrates the candidate's achievements and contributions. Special attention will be given to the influential inspiration of the candidate to the coming generation of landscape architects.</p> <p>The CSLA Board of Directors retains the right to request additional information on candidates as deemed necessary during deliberations.</p>

Checklist:

The Nomination package must be sent in a single .pdf file to the CSLA's Executive Director by email at executive-director@csla-aapc.ca and include the following:

- the completed nomination form;
- a letter of nomination describing the qualifications of the nominee to receive the award (no more than five pages in length);
- a photo of the nominee in .jpg format;
- a résumé (curriculum vitae) of the nominee's work experience and projects that relate to landscape architecture;
- a letter of support from a colleague outside of the nominee's current place of employment;
- additional supporting materials (to a maximum of 15 pages) such as photographs of projects and articles.
