

Lifetime Achievement Award Nomination Guidelines and Form

<p>Purpose</p>	<p>The Lifetime Achievement Award is the honour the CSLA may bestow upon a landscape architect whose lifetime achievements and contributions to the profession have had a unique and lasting impact on the welfare of the public and on the environment.</p> <p>The Lifetime Achievement Award will be awarded to an individual who exemplifies the following qualities by demonstrating:</p> <ul style="list-style-type: none"> ○ excellence in the field of practice as a landscape architect (such as policy, research, project planning ,design, or a combination of professional activities); ○ societal, technical or environmental advancement through landscape architecture; ○ that their contributions have had a substantial meaningful impact on both people and nature and that their works are known and respected by other landscape architects ○ advancement of the profession of landscape architecture through professional and personal contributions; and ○ a passion and enthusiasm for the profession of landscape architecture.
<p>Eligibility</p>	<p>The individual must be:</p> <ul style="list-style-type: none"> ○ a landscape architect, and ○ a member of the CSLA. <p>INELIGIBLE CANDIDATES Current members of the CSLA Board of Directors.</p> <p>RESTRICTIONS An individual may receive only one Lifetime Achievement Award in their lifetime.</p>
<p>Frequency</p>	<p>One medal may be awarded annually.</p>
<p>Nomination</p>	<p>Nominations may be made by any Member of the CSLA, any component organization of the CSLA, or by any associated organization of the CSLA.</p>
<p>Deadline</p>	<p>Nominations must be received at the CSLA office by 4 p.m. (EDT) on April 10th, 2020.</p>
<p>Selection</p>	<p>Each nomination is judged for the success with which the nomination package demonstrates the candidate’s lifetime achievement and contribution to landscape architecture.</p> <p>The CSLA Board of Directors retains the right to request additional information on candidates as deemed necessary during deliberations.</p>

Checklist:	<p>The Nomination package must be sent in a single .pdf file to the CSLA's Executive Director by email at executive-director@csla-aapc.ca and include the following:</p> <ul style="list-style-type: none">○ the completed nomination form;○ a letter of nomination describing the qualifications of the nominee to receive the Medal (no more than five pages in length);○ a photo of the nominee (as applicable);○ a résumé (curriculum vitae) of the nominee's work experience and projects that relate to landscape architecture;○ additional supporting materials (to a maximum of 15 pages) such as photographs of projects and articles;○ a minimum of three (3) and a maximum of five (5) letters of endorsement.
