The CSLA Board of Governors requested that the OALA Representative chair a committee on CSLA Media Access and Marketing concerns. The marketing strategy which was subsequently proposed to the Board of Governors contained the following recommendations:

- ❖ Audit the CSLA component associations with respect to existing marketing resources, key issues and target markets.
- ❖ Promote the CSLA as a Resource House of marketing tools.
- ❖ Promote communication with the CSLA component associations.
- ❖ Promote the CSLA Annual Awards Program.
- ❖ Enhance the national profile of the profession by supporting an appropriate national program and by raising funds for a chosen charity.
- ❖ Initiate a National Advertising Campaign (a task which would involve a substantial budget and thus may not be readily achievable in the short term).

A review was undertaken of the practical relationship between the CSLA and a host association in the planning of a CSLA Annual Conference. The review addressed the definition and re-establishment of areas of responsibility, and the development of a more realistic approach to financial concerns.

Currently, the various marketing contacts for each of the CSLA component associations have been contacted and requested to complete a marketing survey. The intention is to coordinate the sharing of marketing information among the associations and to reduce duplication of efforts in marketing.

In addition to identifying the marketing efforts undertaken by each CSLA component association, the survey requested information on the perceived marketing needs of each association. The results of this survey will be used as the basis for development of a CSLA Resource Manual for Marketing, and will in part determine whether or not a marketing consultant will need to be involved in the preparation of the manual.

The 1993 annual meeting of the Landscape Architecture Canada Foundation (LACF) was held in Montreal, Quebec, at the time of the Annual CSLA Congress. The financial report indicated that donations and other revenues were up from \$8,037 to \$10,034 in 1992. Total assets stood at \$36,646 at that time. Business included the appointment of Gunter Schoch, FCSLA, as Treasurer; a discussion on fundraising strategies; and the establishment of grants policy for the coming year.

The LACF completed its second formal round of consideration of requests for grant proposals in the fall of 1993. The objective of this program is to support research, education and communications in the field of landscape architecture. The Grants Committee, chaired by Cecelia Paine, included Don Graham, Gary Hilderman, John MacLeod, and Len Novak.

This year six proposals were received and we are pleased to announce the following grants:

- To Charlie Thomsen, FCSLA, Professor of Landscape Architecture at the University of Manitoba, \$1,000 to develop a "Guidebook to Historic Landscapes of Manitoba". This document will use the material included in

an exhibit (shown in Winnipeg and at the CSLA Congress in Montreal) which illustrates significant designed and vernacular landscapes in the Province.

- To Linda LeGeyst, \$1,000 to help support "Oral history interviews of senior Canadian practitioners of landscape architecture". This project will involve interviewing twenty landscape architects with the intent of collecting information about their knowledge and ideas regarding the practice of landscape architecture in Canada. This historic perspective will provide a data base for a manuscript for publication and will serve as a reference source for future researchers.

It should be noted that the requests were of a high calibre this year, and that proposals will be invited again in September for the next round of grants.

The 1994 annual meeting of the LACF will be held in Victoria, BC, in conjunction with the CSLA Congress in March.
